#### Regents Appoints Members to Advisory Council on Libraries

At its October meeting, the New York State Board of Regents appointed Greg Benoit, Director of the Gates Public Library; Tatiana Bryant, Assistant Professor and Outreach and Promotion Librarian at Adelphi University; Timothy Burke, Executive Director of the Upper Hudson Library System; Brian Hildreth, Executive Director of the Southern Tier Library System and **Grace Riario**, Assistant Director and Outreach Coordinator of the Ramapo Catskill Library System to the Regents Advisory Council on Libraries for terms beginning November 1, 2018.

Grace Riario, RCLS Assistant Director and Outreach Coordinator was appointed to a five-year term. Previously, Grace was Head of Teen Services and the Adult Reference Librarian at Valley Cottage Library. She earned her Masters of Library and Information Science from Queens College, her Masters of Public Administration from Penn State University, and an Advanced Certificate in Public Library Administration from Long Island University. Her professional activities include serving on the New York Library Association (NYLA) Council and serving as a NYLA Library Association (NYLA) Council and serving as a NYLA Library Assistant Program Instructor. Grace is an Executive Board member of the Ethnic Services Roundtable. The session will include the sexual harassment prevention training workshop based on the New York State Department of Labor final model of a training program made public on October 1, 2018. The training will be interactive as required by law. PLUS participants will have the opportunity to ask legal questions regarding the law, the policy and the requirements as an employer.

## Presenter

Ellen Bach practices principally in the area of labor and employment law and litigation. Ms. Bach represents public and private employers in federal and State courts, labor arbitrations, and administrative proceedings before the U.S. Equal Employment Opportunity Commission, U.S. Department of Labor, New York State Division of Human Rights, New York State Department of Labor, and other administrative agencies.
