State Law Requires Public Library Trustees to Take Oath of Office

Many library trustee terms begin on January 1. This is an important reminder that New York State <u>Public Officer's</u>

Law §10 requires all public library trustees (except association library trustees) to take an oath of office within 30 days of beginning their term of office. Public library trustees are public officers and the oath of



office is required to officially undertake and perform the duties of a public library trustee. The board approved Treasurer must also take the oath of office.

If a public library trustee does not properly complete and file an oath of office, the trustee's position may be deemed vacant. See <u>Public Officer's Law \$30(1)(h)</u>.
